ON
ESTABLISHMENT OF MEDICAL COMMISSION OF
THE NATIONAL SOCIAL SECURITY FUND**

MINISTER OF MINISTRY OF HEALTH**

- Having seen the Constitution of Kingdom of Cambodia;
- Having seen Royal Kret No. NS/RKT/0908/1055, dated 15 September 2008, concerning the Termination of Royal Government and the Nomination of Kingdom of Cambodia in the 4th Legislature of National Assembly;
- Having seen Royal Kram No. 02/NS/94, dated 20 July 1994, promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Having seen Royal Kram No. NS/RKM/0105/003, dated 17 January 2005, promulgating the Law on the Establishment of Ministry of Labour and Vocational Training;
- Having seen Royal Kram No. NS/RKT/0196/06, dated 24 January 1996, promulgating on the Establishment of Ministry of Health;
- Having seen Royal Kram No. NS/RKM/0902/018, dated 25 September 2002, promulgating the Law on the Social Security Schemes for Persons Defined by the Provisions of the Labour Law;
- Having seen Royal Kret No. NS/RKT/1297/91, dated 31 December 1997, concerning Judicial Statute of Public Administrative Enterprise;
- Having seen Sub-Decree No. 20 SD/LV, dated 30 April 1996, concerning the Organization and Functioning of Ministry and Secretariat;
- Having seen Sub-Decree No. 52 SD/E, dated 01 April 2005, concerning the Organization and Functioning of Ministry of Labour and Vocational Training;
- Having seen Sub-Decree No. 67 SD/LV, dated 22 December 1997, concerning the Organization and Functioning of Ministry of Health;
- Having seen Sub-Decree No. 16 SD/E, dated 02 March 2007, concerning the Establishment of the National Social Security Fund;
- Reference to the Compulsory of Governing Body of the National Social Security Fund.

HEREBY DECIDED

Article 1.~

The medical commission attached to the National Social Security Fund whose 03 compositions are as follows:

1. Representative of Ministry of Labour and Vocational Training **President**
2. Representative of Ministry of Health **Vice President**
3. Representative of Ministry of Health **Member**

This commission shall have 02 reserved members—01 member represents Ministry of Labour and Vocational Training and 01 member represents Ministry of Health. The reserved members shall attend the meeting in compliance with invitation of president or action president.

In case that president is absent, vice president shall act as action president.

In case that president and vice president are absent, the members have rights to invite the reserved members to attend and lead the meeting.

Article 2.~

The members of medical commission shall attend the meeting in compliance with invitation of president.

The members of medical commission shall be nominated among the medical officials that have duties as set forth in Article 3 in this Prakas.

Article 3.~

The medical commission shall have duties to consult the determination of degree of permanent disability of worker suffering from work injury and level of care of health facility and poly-clinic recognized by NSSF.

In any necessary case, the medical commission may invite the general practitioner or specialist to clarify after receiving the approval from NSSF. The expense of inviting the general practitioner or specialist to participate in such work is borne by NSSF.

Article 4.~

The decision of medical commission may come into force as long as there are absolutely most votes.

Article 5.~

The functional incentive of medical commission shall be regulated by the Governing Body of the National Social security Fund.

Article 6.~

The National Social Security Fund, all health facilities, and authorized organizations shall collaborate and facilitate in order to enable the medical commission of the National Social Security Fund to implement its own duties effectively.

Article 7.

This Prakas shall come into force from the signed date.
