**DECISION  
ON  
ESTABLISHMENT OF ROAD TRAFFIC SAFETY TEAM FOR WORKER PREVENTION**

- Having seen the Constitution of Kingdom of Cambodia;
- Having seen Royal Kret No. NS/RKT/0908/1055, dated 25 September 2008, concerning the Nomination of Royal Government of Kingdom of Cambodia;
- Having seen Royal Kram No. 02/NS/94, dated 20 July 1994, promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Having seen Royal Kram No. NS/RKM/0397/01, dated 13 March 1997, promulgating the Law on the Labour Law;
- Having seen Royal Kram No. NS/RKM/0902/018, dated 25 September 2002, promulgating the Law on the Social Security Schemes for Persons Defined by the Provisions of the Labour Law;
- Having seen Royal Kram No. NS/RKM/0105/003, dated 17 January 2004, promulgating the Law on the Establishment of Ministry of Labour and Vocational Training;
- Having seen Royal Kret No. NS/RKT/1297/91, dated 31 December 1997, concerning the Judicial Statute of Public Administration Establishment;
- Having seen Sub-Decree No. 52 SD/E, dated 01 April 2005, concerning the Organization and Functioning of Ministry of Labour and Vocational Training;
- Having seen Sub-Decree No. 16 SD/E, dated 02 March 2007, concerning the Establishment of the National Social Security Fund;
- Reference to the Necessity of Ministry of Labour and Vocational Training.

## HEREBY DECIDED

### Article 1.~

Road Traffic Safety Team for Worker Prevention shall be established, called “RTSTW”. This team has compositions as follows:

**Article 2.~**

The Road Traffic Safety Team for Workers has duties as follows:

- To build the action plans aimed at preventing the commuting accident happening unexpectedly
- To study, collect data, and analyze the major causes leading to the commuting accident
- To survey by means of workers' transportations and worker-transporting drivers nationwide
- To take measures on dissemination on the Law and Road Traffic Safety to the worker-transporting drivers and workers
- To collaborate with the local authorities, relevant authorities, as well as water traffic authorities with a view to inspecting by means of workers' transportation from the first point of departure and facilitate in the event that victim suffer from the traffic accident
- To implement other duties in compliance with orders of the Minister of Ministry of Labour and Vocational Training.

**Article 3.~**

The Road Traffic Safety Team for Worker Prevention shall attend the meeting at least once every three months. The president can convene the extraordinary meeting when necessary. This team possesses the secretariat in the National Social Security Fund.

**Article 4.~**

The expense of materials and transportations of the Road Traffic Safety Team for Worker Prevention in order to fulfill the work shall be borne by the National Social Security Fund.

**Article 5.~**

This team can find and consume the fund source, materials, and technics from the development partners.

**Article 6.~**

Any regulations contrary to this Decision shall be abrogated.

**Article 7.~**

President, Vice President, and Members as stipulated in Article 1 and Executive Director of the National Social Security Fund shall implement this decision effectively from the dated sign.
