#### HEREBY DECIDED

# Article 1.~

One composition of Road Traffic Team for Worker Prevention of the National Social Security Fund shall be added.

## Article 2.~

H.E. Mom Chanthy, Deputy Director of Department of Health of Cambodian Red Cross, was nominated as a member of Road Traffic Team for Worker Prevention of the National Social Security Fund.

#### Article 3.~

Any regulations contrary to the decision shall be abrogated.

#### Article 4.~

This decision shall be implemented effectively from the signed date.
