SUB-DECREE

ON

THE ORGANIZATION AND FUNCTIONING OF THE MEDICAL COUNCIL OF THE NATIONAL SOCIAL SECURITY FUND

- Having seen Sub-Decree No. 196 SD.E dated 30 November 2020 concerning the Organization and Functioning of the National Social Security Fund (NSSF);
- Reference to the proposal of Minister of Labour and Vocational Training and Minister of Health.

HEREBY DECIDED CHAPTER I GENERAL PROVISIONS

Article 1 ._

This sub-decree determines the organization and functioning of MC-NSSF, an acronym for the Medical Council of the National Social Security Fund, in order to promote quality and effectiveness of services provided by the health facilities signed the agreement with NSSF.

Article 2 ._

This sub-decree is applied to the health facilities signed the agreement with NSSF and health facilities or institutions related to providing health services to the NSSF members.

CHAPTER II COMPOSITIONS OF MC-NSSF

Article 3 ._

The compositions of MC-NSSF are as follows:

- 1- Representative of Ministry of Labour and Vocational Training 01 President
- 2- Representative of Ministry of Health 01 Vice President
- 3- Dignitary with experience in medical profession 08 Member
- 4- Director of Health Facility Services Department of NSSF Permanent Member

The actual compositions of MC-NSSF shall be appointed by Decision of the Royal Government.

Article 4 ._

The candidacy of MC-NSSF shall be elected among officials or dignitaries with qualifications and experience as follows:

- Have Khmer nationality;
- Hold degree in medical profession with at least 10 (ten) years of working experience;
- Have never been convicted of any misdemeanors or felonies.

The MC-NSSF President who is the representative of Ministry of Labour and Vocational Training shall be a dignitary with specialist degree and experience in medical profession.

The candidacy of dignitaries stated in Article 3 of this sub-decree shall be proposed by the NSSF Director General with the approval of the NSSF Governing Body.

Other compositions of MC-NSSF, except the Permanent Member, shall be appointed for a five-year mandate.

CHAPTER III ROLES AND DUTIES OF MC-NSSF

Article 5 ._

MC-NSSF has roles and duties as follows:

- Monitor the implementation of agreements and evaluate the service quality of the health facilities signed the agreement with NSSF;
- Check and advise on the conditions and criteria of the health facilities requesting to sign the agreement with NSSF;
- Study, prepare, and revise the list of permanent disability degree for Occupational Risk Scheme;
- Review and approve the determination of permanent disability degree of the NSSF members sustaining the occupational risk that is not set forth in the list of permanent disability degree at the request of physician recognized by NSSF;
- Study, research, and propose preparing legal instruments on the determination of occupational disease types;
- Examine and approve situation of disability and chronic disease of beneficiaries of survivors' pension for Occupational Risk, Health Care and Pension Schemes;
- Study and approve invalidity status and occupational disease types;

- Study and determine the conditions or general situations required to have a caretaker for Occupational Risk Scheme;
- Study, prepare, review, and advise on the revision of provider payment methods;
- Check and advise on the selection of physician recognized by NSSF;
- Perform other duties assigned by the NSSF Director General.

CHAPTER IV FUNCTIONING OF MC-NSSF

Article 6 .-

MC-NSSF shall convene quarterly ordinary meetings as per invitation of the President. The President may convene the extraordinary meeting where necessary.

In the absence of the MC-NSSF President, the President may authorize the Vice President to chair the meeting on behalf.

The meeting of MC-NSSF may be convened only if there is over 50 percent of the total members.

The decision of MC-NSSF may be deemed valid only if there is unanimous consent of the members who have attended the meeting.

Article 7 ._

The Department of Health Facility Services of NSSF is the secretariat of MC-NSSF.

Article 8 ._

MC-NSSF may establish the ad hoc technical commission where necessary by the decision of the MC-NSSF President.

MC-NSSF may invite professional medical doctors or specialists to advise on its own work where necessary after the approval of the NSSF Director General.

Article 9 ._

The MC-NSSF expenditure for fulfilling duties is borne by NSSF in accordance with the decision of the NSSF Governing Body.

Article 10 ._

MC-NSSF has the right to use the NSSF stamp for its own work.

CHAPTER V TRANSITIONAL PROVISIONS

Article 11 ._

Every existing legal instrument related to the NSSF Medical Commission shall remain effective until there are new legal instruments in accordance with this sub-decree.

CHAPTER VI FINAL PROVISIONS

Article 12 ._

Joint Prakas No. 088/09 LV/PrK dated 27 April 2009 concerning the Establishment of Medical Commission of the National Social Security Fund and any provisions contrary to this sub-decree shall be abrogated.

Article 13 ._

Minister in charge of the Office of the Council of Ministers, Minister of Economy and Finance, Minister of Labour and Vocational Training, Minister of Health, all relevant Ministers and Heads of Institutions, and Director General of the National Social Security Fund shall comply with this sub-decree respectively from the date of signature.
