THE DETERMINATION OF CONTRIBUTORY SALARY OR WAGE

HEREBY DECIDED CHAPTER I GENERAL PROVISIONS

Article 1 ._

This sub-decree determines the contributory salary or wage by the mandatory contributions in Social Security Schemes on Occupational Risk, Health Care, Pension, and Unemployment as stated in the Law on Social Security Schemes promulgated by Royal Kram No. NS/RKM/1119/018 dated 2 November 2019.

Article 2 ._

This sub-decree has the scope of implementation to the contributory salary or wage of the defined persons as follows:

- 1. Persons under the public sector consisting of:
 - Officials in the civil service serving at the ministries, institutions, and units at national and sub-national levels that are defined by the provisions of the Law on the Common Statutes of Civil Servants of the Kingdom of Cambodia;
 - Officials defined by the Law on the Statutes of Officials of the Legislative Group with the exception of Pension Scheme;
 - Officials serving at the judicial institutions;
 - National police officers and prison officers receiving only the medical care benefit of Health Care Scheme;
 - Officials serving at the National Election Committee;
 - Officials serving at the National Audit Authority;
 - Former civil servants and veterans;
 - Contract officials serving at the ministries, institutions, and units at national and sub-national levels recognized by Ministry of Civil Service;
 - Persons in other public sectors regulated by sub-decree.
- 2. Persons defined by the provisions of the Labour Law including personnel serving in the air and maritime transportation as well as domestic workers.

CHAPTER II CONTRIBUTORY SALARY OR WAGE

Article 3 ._

Contributory salary of Pension Scheme for persons in the public sector shall be regulated by the separate sub-decree.

Contributory salary of Occupational Risk and Health Care Schemes for persons in the public sector shall be complied with applicable legal instruments.

Contributory salary is the salary of persons in the public sector required to be contributory by law, the pension of persons in the public sector with permanent disability from 20% (twenty per cent) or more, or the pension of former civil servants and veterans required to be contributory in Health Care Scheme.

Article 4 ._

The minimum contributory wage shall be equivalent to 400,000 (four hundred thousand) Riels, while the ceiling contributory wage shall be equivalent to 1,200,000 (one million and two hundred thousand) Riels.

Contributory wage is the wage of workers required to be contributory by law, the pension of workers with permanent disability from 20% (twenty per cent) or more, or the pension of workers required to be contributory in Health Care Scheme.

The revision of the minimum and ceiling contributory wages shall be regulated by Inter-Ministerial Prakas of Ministry of Labour and Vocational Training and Ministry of Economy and Finance at the request of the NSSF Governing Body.

CHAPTER III FINAL PROVISIONS

Article 5 ._

Any provisions contrary to this sub-decree shall be abrogated.

Article 6 ._

Minister in charge of the Office of the Council of Ministers, Minister of Economy and Finance, Minister of Labour and Vocational Training, and all relevant Ministers and Heads of Institutions shall comply with this sub-decree respectively from the date of signature.
