ON
THE FORMALITIES AND PROCEDURES OF FUNERARY GRANT PROVISION OF
SOCIAL SECURITY SCHEME ON PENSION FOR PERSONS DEFINED BY
THE PROVISIONS OF THE LABOUR LAW**

CHAPTER I
GENERAL PROVISIONS

Article 1 .-

This prakas aims to determine the formalities and procedures of funerary grant provision of Social Security Scheme on Pension for persons defined by the provisions of the Labour Law in order to ensure effectiveness and efficiency of the social security schemes implementation.

Article 2 .-

This prakas has the scope of implementation to the funerary grant of Social Security Scheme on Pension for persons defined by the provisions of the Labour Law. The funerary grant includes the NSSF members – both mandatory and voluntary members.

Article 3 .-

The key technical terminology used in this prakas is defined as follows:

- ***Beneficiary of Funerary Grant*** refers to the person who is entitled to receive the funerary grant, including the beneficiary of survivors' pension or any person who takes responsibility for holding the funeral.
- ***Old-Age Pensioner*** refers to the person who meets the conditions to receive the old-age pension.
- ***Invalidity Pensioner*** refers to the person who meets the conditions to receive the invalidity pension.
- ***Funerary Grant*** refers to the allowance for holding the funeral of the old-age pensioner or invalidity pensioner who passed away.

CHAPTER II
FUNERARY GRANT PROVISION

Article 4 .-

The funerary grant of Pension Scheme shall be equivalent to 5 (five) months of the last pension of the person concerned. The funerary grant of old-age pensioner or invalidity pensioner shall be set a minimum of 2,000,000 (two million) Riels.

Article 5 .-

The beneficiary of funerary grant shall fill out the Claim Form of “**Benefit of Pension Scheme**” and attach a copy of death certificate or other documents recognized by NSSF.

The Claim Form of “**Benefit of Pension Scheme**” shall be determined by the NSSF Director General.

The beneficiary of funerary grant who takes responsibility for holding the funeral of old-age pensioner or invalidity pensioner shall fill out the claim form of funerary grant within 3 (three) months after the date of the pensioner's death.

Article 6 .-

The beneficiary of funerary grant or any person who takes responsibility for holding the funeral shall notify the death to NSSF within 2 (two) weeks counting from the date of death of the old-age pensioner or invalidity pensioner.

The funerary grant given to the beneficiary of survivors' pension shall be paid with the benefits of old-age pension or invalidity pension which were paid to the person concerned after death.

CHAPTER VII FINAL PROVISIONS

Article 7 .-

Director of Cabinet, Director General of the General Department of Administration and Finance, Director General of the National Social Security Fund, and all relevant Heads of Units of Ministry of Labour and Vocational Training shall comply with this prakas respectively from the date of signature.
