**HEREBY DECIDED**  
**CHAPTER I**  
**GENERAL PROVISIONS**

**Article 1..**

The Governing Body of the National Social Security Fund is appointed in the first mandate.

7. <b>Oknha Nang Sothy</b>	Representative of Employers	Member
8. <b>Oknha Sok Piseth</b>	Representative of Employers	Member
9. <b>Mr. Ath Thorn</b>	Representative of the NSSF member	Member
10. <b>Mr. Heng Bunchhun</b>	Representative of the NSSF member	Member
11. <b>H.E. Ouk Samvithyea</b>	Director General of NSSF	Permanent Member

**Article 2..**

Any regulations contrary to this sub-decree shall be abrogated.

**Article 3..**

Minister in charge of the Office of the Council of Ministers, Minister of Economy and Finance, Minister of Labour and Vocational Training, all relevant Ministers and Heads of Institutions, and persons concerned shall comply with this sub-decree respectively from the date of signature.
