DETERMINATION OF THE CHRONIC DISEASE LIST
IN THE SOCIAL SECURITY SCHEMES ON HEALTH CARE**

- Having seen Sub-Decree No. 16 SD.E, dated 02 March 2007, concerning the Establishment of the National Social Security Fund;
- Having seen Sub-Decree No. 01 SD/E, dated 06 January 2016, concerning the Establishment of Social Security Schemes on Health Care for Persons Defined by the Provisions of the Labour Law;
- Having seen Prakas No. 109 LV/PrK., dated 17 March 2016, on Health Care Benefit;
- Reference to the 33th Meeting of the Governing Body of the National Social Security Fund in the 3rd mandate, dated 19 May 2016.

HEREBY DECIDED

Article 1.

This Prakas aims to prescribe the chronic disease list in the Social Security Schemes on Health Care for Persons Defined by the Provisions of the Labour Law.

Article 2.

The types of chronic disease defined in this Prakas set as follows:

1. Cardiac Failure
2. Cardiomyopathy
3. Chronic Hepatitis B
4. Chronic Hepatitis C
5. Chronic Renal Disease
6. Cirrhosis of the Liver
7. Coronary Artery Disease
8. Diabetes Mellitus Type 1 & 2
9. Dysrhythmias
10. Multiple Sclerosis
11. Schizophrenia
12. Systemic Lupus Erythematosus
13. Hypertension
14. Thalassemia

Article 3.

The National Social Security Fund shall be responsible for providing the chronic disease services as stipulated in Article 2 in this Prakas in compliance with the determination of Article 5 in Prakas No. 109 LV/PrK., dated 17 March 2016, on Health Care Benefit.

Article 4.

The revision of chronic disease list as stipulated in Article 2 of this Prakas shall be regulated by Prakas of the Minister of Ministry of Labour and Vocational Training.

Article 5.

Any regulations contrary to this Prakas shall be abrogated.

Article 6.

The National Social Security Fund, workers, employers, and health facilities signed the agreement with NSSF shall have duties to implement this Prakas respectively from the signed date.
