ON
THE INCLUSION OF HEALTH PREVENTION SERVICES IN SOCIAL SECURITY
SCHEMES ON HEALTH CARE**

- Having seen Royal Kram No.02/NS/94, dated 20 July 1994, promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Having seen Royal Kram No. NS/RKM/0105/003, dated 17 January 2005, promulgating the Law on the Establishment of Ministry of Labour and Vocational Training;
- Having seen Royal Kram No. CHS/RKM/0397/01, dated 13 March 1997, promulgating the Labour Law;
- Having seen Royal Kram No. NS/RKM/0902/018, dated 25 September 2002, promulgating the Law on the Social Security Schemes for Persons Defined by the Provisions of the Labour Law;
- Having seen Sub-Decree No. 283 SD.E, dated 14 November 2014, concerning the Organization and Functioning of Ministry of Labour and Vocational Training;
- Having seen Sub-Decree No. 16 SD.E, dated 02 March 2007, concerning the Establishment of the National Social Security Fund;
- Having seen Sub-Decree No. 01 SD.E, dated 06 January 2016, concerning the Establishment of Social Security Schemes on Health Care for Persons Defined by the Provisions of the Labour Law;

- Having seen Prakas No. 109 LV/PrK., dated 17 March 2016, on Health Care Benefits;
- Reference to the necessity of Ministry of Labour and Vocational Training.

HEREBY DECIDED

Article 1.~

This Prakas aims to include health prevention services in the Social Security Schemes on Health Care for Persons Defined by the Provisions of the Labour Law.

Article 2.~

Health prevention services are included in this Prakas as follows:

1. Rabies Vaccination
2. Antirabic Serum
3. Anti-Tetanus Serum
4. Antivenom Immunoglobulin
5. Blood test of goiter including TSH (Thyroid-Stimulating Hormone), Free T3 (Free Triiodothyronine), and Free T4 (Free Thyroxine)
6. Blood test of Cancer Humeraux Marqueurs after cancer treatment by surgery, chemotherapy, and/or radiotherapy comprising: CA15-3 (Cancer Antigen 15-3), CA 19-9 (Cancer Antigen 19-9), CA 125 (Cancer Antigen 125), PSA (Prostate-Specific-Antigen), -HCG (Beta-Human Chorionic Gonadotropin).

Health prevention services as stipulated in this Prakas shall be granted by public health facilities or public institutes.

These services shall be not reimbursed if the victims access services in private health facilities or private domestic/abroad laboratories except that there is a prior permission from the National Social Security Fund.

Article 3.~

The National Social Security Fund shall be in charge of providing and determining the provider payment methods for health prevention services as set forth in Article 2 of this Prakas.

Article 4.~

The revision of health prevention services as stipulated in Article 2 of this Prakas shall be regulated by Prakas of the Minister of Ministry of Labour and Vocational Training.

Article 5.~

Any regulations contrary to this Prakas shall be abrogated.

Article 6.~

National Social Security Fund, workers, employers, and health facilities or public institutes signed the agreement with NSSF shall comply with this Prakas from the signed date.
