HEREBY DECIDED

Article 1 .-

This prakas aims to set the date for the implementation of Social Security Scheme on Pension for persons defined by the provisions of the Labour Law as stated in Article 39 of Sub-Decree No. 32 SD.E dated 4 March 2021 concerning the Social Security Scheme on Pension for Persons Defined by the Provisions of the Labour Law.

Article 2 .-

The Social Security Scheme on Pension for persons defined by the provisions of the Labour Law shall be implemented from 1 July 2022 onwards.

Article 3 .-

Director of Cabinet, Secretary-General, Delegate of the Royal Government in charge as Director General, all Directors General, Inspector General of General Inspectorate, the National Social Security Fund, and all relevant Heads of Units under Ministry of Economy and Finance and Ministry of Labour and Vocational Training shall comply with this inter-ministerial prakas respectively from the date of signature.
